#### APPLICATION GUIDELINES

#### Special Selection for International Students

#### Ⅰ 出願資格 Eligibility Requirements

外国人留学生特別入試に出願できる者は、日本の国籍を有しない者で、次のいずれかに該当する者又は2025年3月までに該当する見込みの者

Applicants for the Special Selection for International Students must be non-Japanese nationals who meet one of the following criteria or expect to meet one of the criteria by March 2025.

① 大学を卒業した者

University graduates

② 外国において学校教育における16年の課程を修了した者

Those who have completed 16 years of school education outside Japan

③ 大学院において、個別の入学資格審査により、大学を卒業した者と同等以上の学力があると認めた者で、2025年3月までに22歳に達する者

Those who are recognized as having academic ability equivalent or superior to a university graduate through an individual preliminary screening for admission qualification, and who will reach 22 years of age by March 2025.

④ 大学に3年以上在学した者（これに準ずる者として文部科学大臣が定める者を含む。）で、大学院が定める単位を優秀な成績で修得したと認める者

Those who have been enrolled in a university for 3 years or more (including those who are designated by the Minister of Education, Culture, Sports, Science and Technology as equivalent thereto), and who are recognized as having acquired the credits specified by the graduate school with excellent grades.

#### 2 出願資格における個別の入学資格審査

##### Individual Preliminary Screening for Admission Qualification under Eligibility Requirements

Ⅰの「出願資格」③④に該当する入学志願者は、出願の前に、入学資格認定のための個別の入学資格審査を行いますので、期限までに必要書類（8頁参照）を提出してください。

Applicants who meet the application requirement ③ or ④ under “I Eligibility Requirements” above must submit the required documents (see page 8) by the deadline, as an individual preliminary screening will be conducted prior to application for entrance examination.

#### 3 障がい等のある方の出願 Application by Persons with Disabilities

When a person who is eligible for exemption from the application fee pays the fee and completes the prescribed application procedures due to difficulties in obtaining certificates and other required documents during the application period.

(13) 修学援助 Financial Support

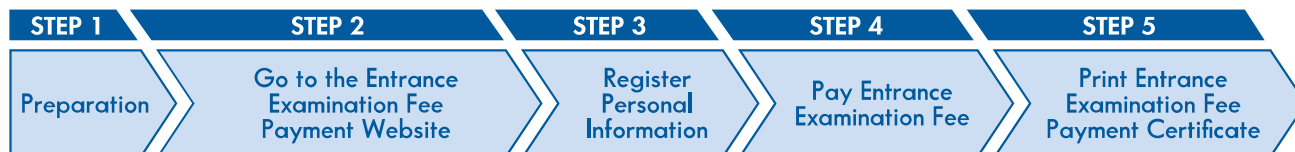

If you selected "Convenience store" or "Pay-easy compatible bank ATM" as your payment method, write down the number that is provided to you after the selection of the payment method, then go to a convenience store or Pay-easy compatible bank ATM to make your payment within the prescribed payment period.

A confirmation email will be sent to you after you complete your registration. If you have restrictions on your inbox, make sure to authorize our domain name (@e-apply.jp). Be aware that the confirmation email may accidentally be sent to your Spam box.



Make sure the information you enter is correct, as you will not be able to revise/change any of this information after registration is complete. You may, however, re-register the correct information and "revise" the information this way, as long as it is before you have made the actual payment. Be aware that if you chose to pay with your credit card, the payment will be made as soon as you register your personal information.

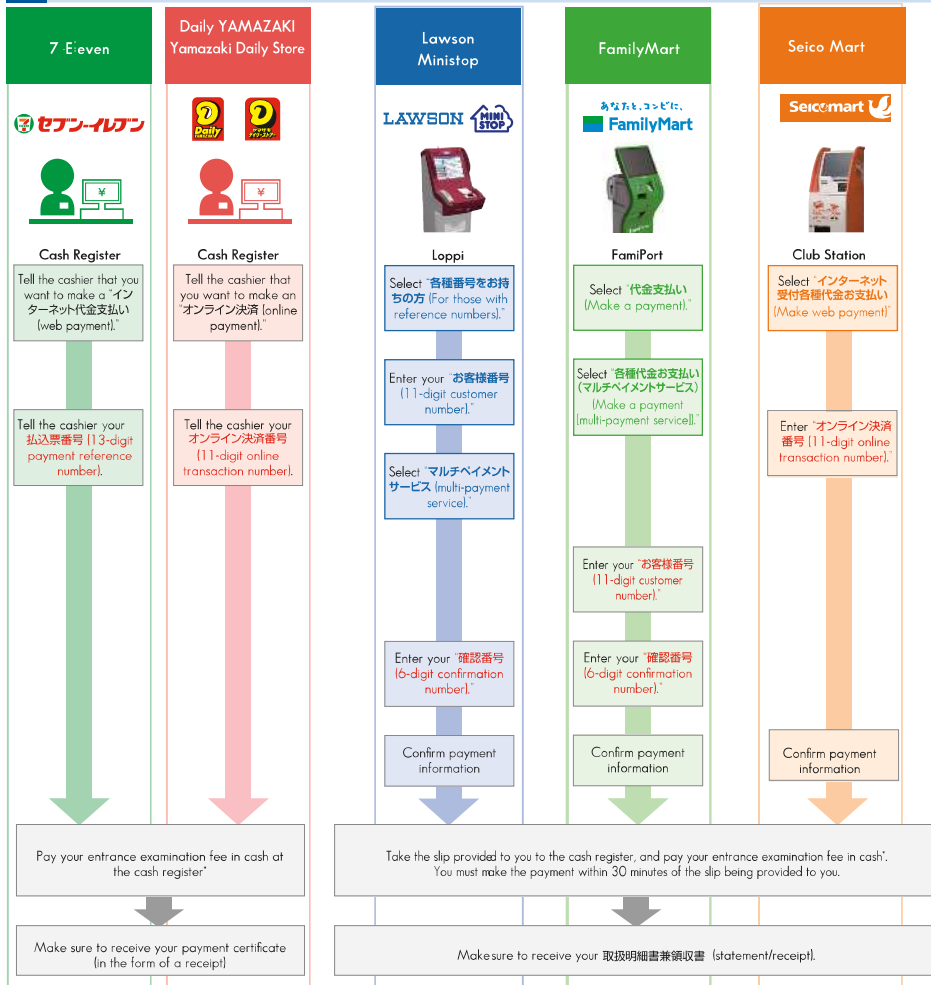

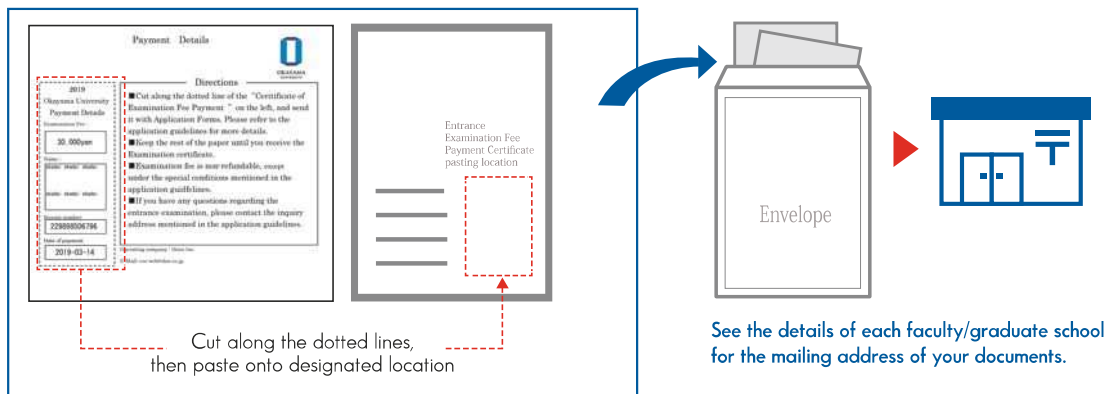

Send this document, along with all other application documents, via "書留・速達郵便 (registered express mail)" at the post office, within the application period. \*See the details of each faculty/graduate school for application deadlines.



## Payment Complete

### Note

Your application will be deemed complete only when you have sent us the required documents (as listed for each faculty/graduate school) and the entrance examination fee payment certificate.  
Your application is NOT complete after you have registered your information.

Payments can be made 24/7. The deadline for registering your personal information and paying your entrance examination fee is 5:00 P.M. (JST) on the last day of the application period (business hours differ according to convenience store, ATM, etc.). Make sure to send the necessary documents via postal mail within the period prescribed by each faculty/graduate school. Try to complete your application well in advance of the deadline.
